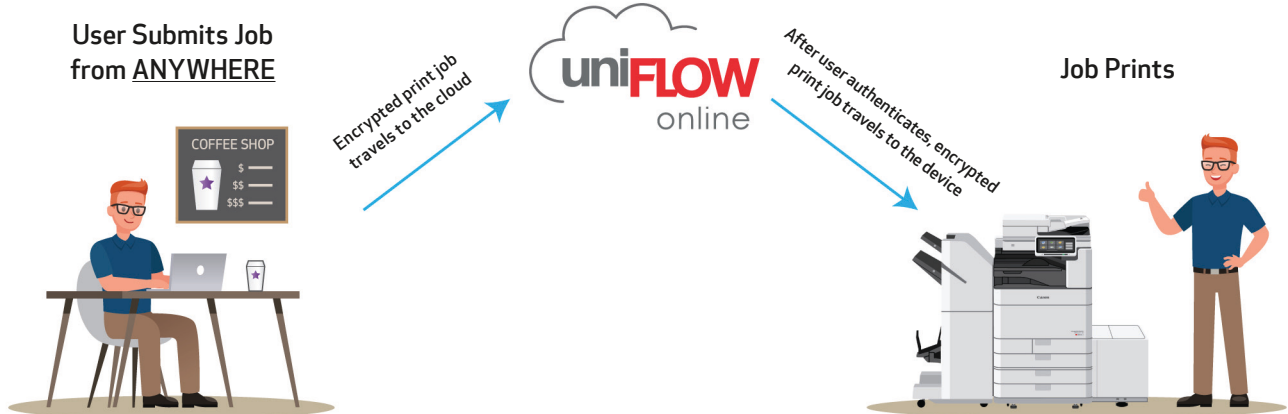


## PRINTING

### Print Via Cloud

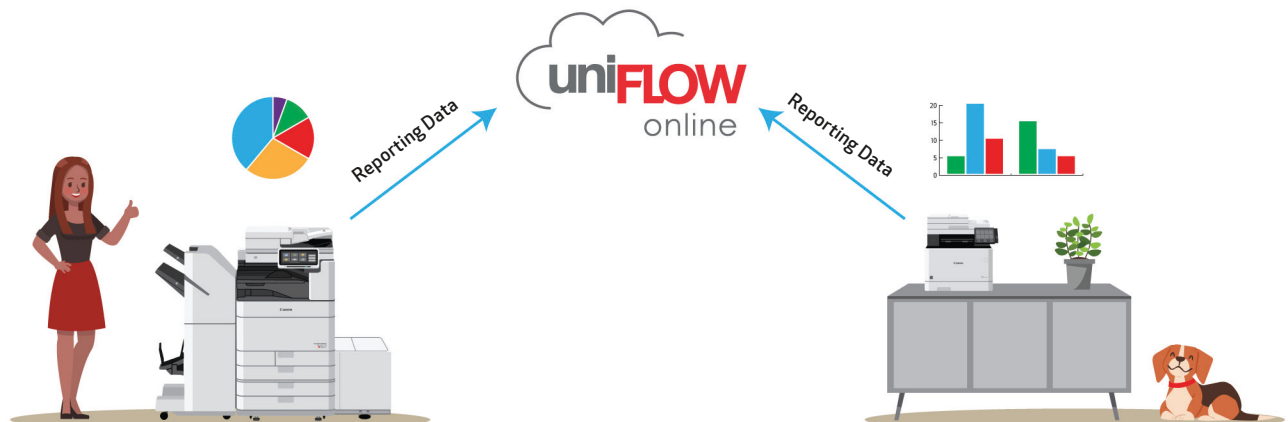


## TRACKING/REPORTING

### Consolidated Reporting, No Matter Where the Device is Located



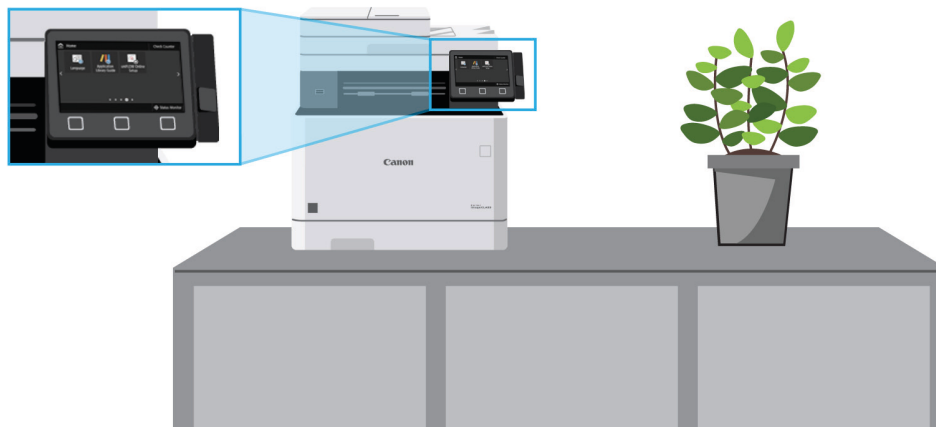
## CLOUD

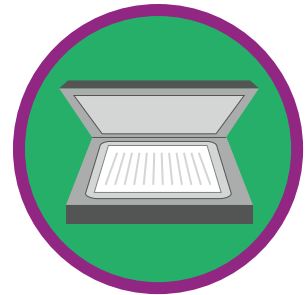

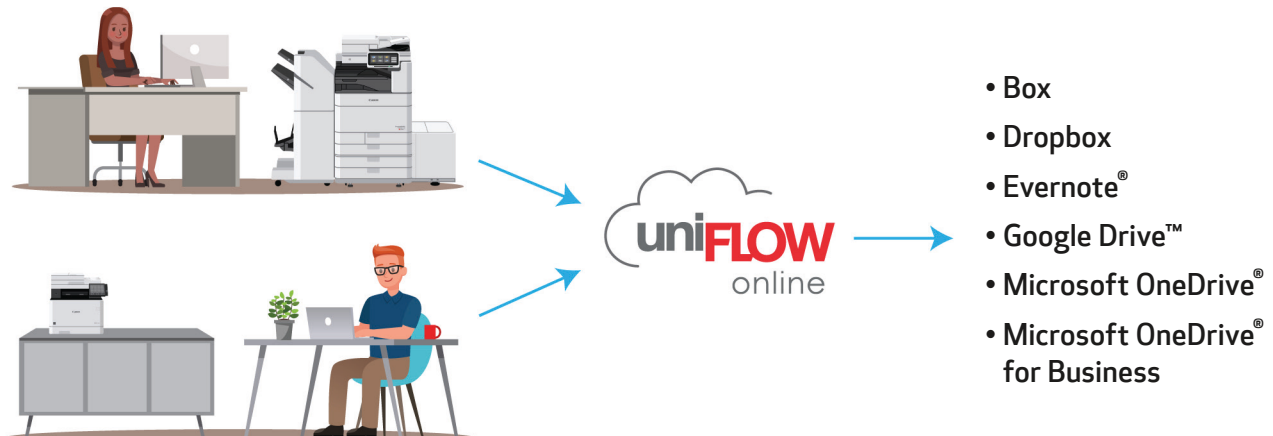


## SCANNING
